HARRIS and ANDREW C. HARRIS, II, WIFE and HUSBAND** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **THOMAS E. EDWARDS and KIMBERLY J. EDWARDS**, (herein referred to as "Grantees") , as joint tenants with rights of survivorship, her interest in the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 131, according to the Survey of Grand View Garden and Townhomes, First Addition, as recorded in Map Book 26, Page 16, in the Probate Office of Shelby County, Alabama.


Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2006 and subsequent years not yet due and payable.


\$116,000.00 of the purchase price recited herein was paid from the proceeds of a mortgage loans closed simultaneously herewith.



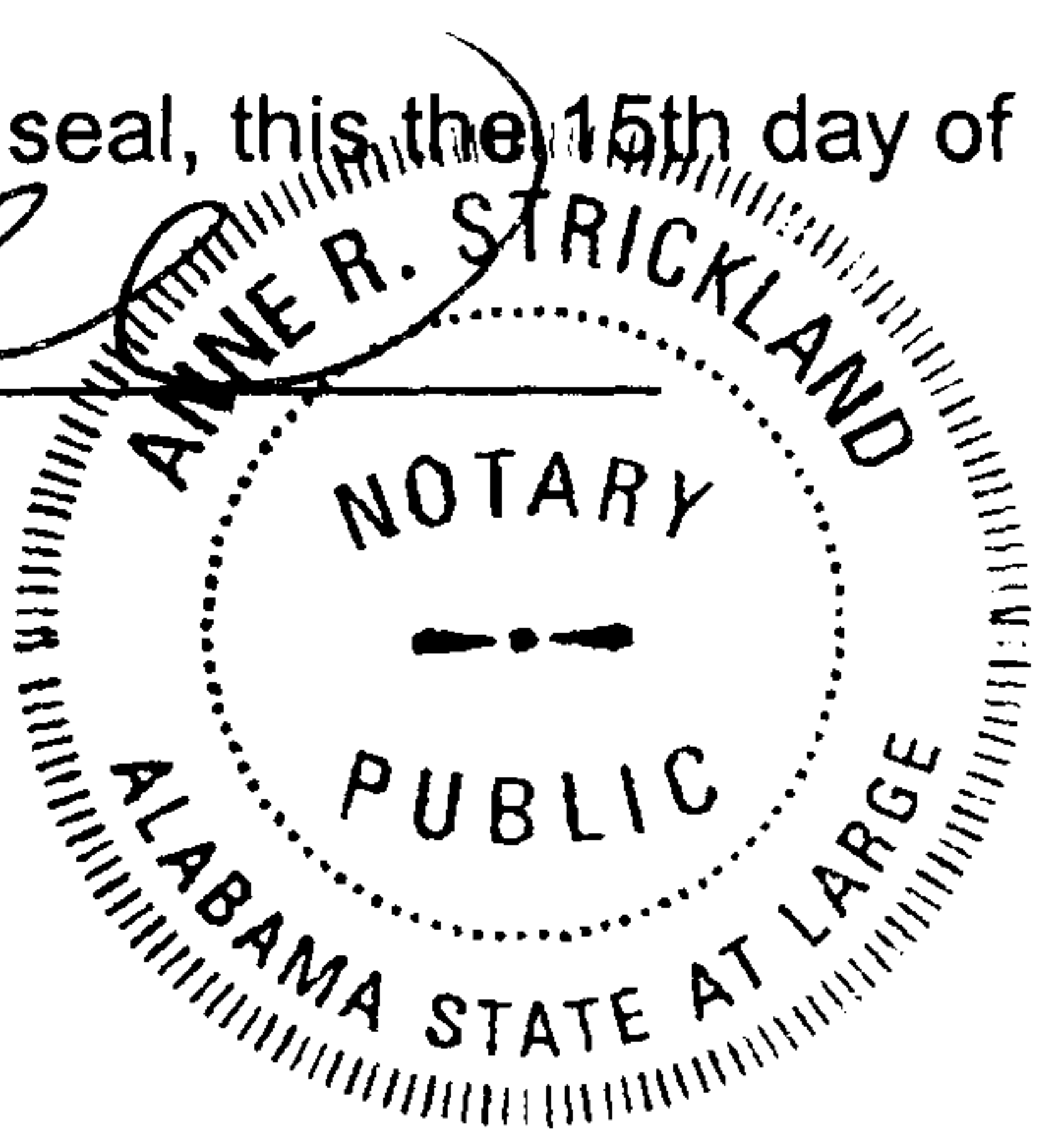
