JOINT SURVIVORSHIP DEED

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Million Eight Hundred Thirty-Three Thousand and 00/100 (\$1,833,000.00), and other good and valuable consideration, this day in hand paid to the undersigned Sharon K. Kelley, and husband, Ronald T. Kelley, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, Robert A. Johnson and Elizabeth A. Johnson, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot Number Twenty (20), according to the Survey of the Amended Map of The Crest at Greystone, as recorded in Map Book 18, Page 17 A, B, C & D, in the Office of the Judge of Probate of Shelby County, Alabama.
