


Description of Real Property

Parcel III

Begin at the Southeast corner of the Southwest ¼ of the Northeast ¼ of Section 23, Township 19 South, Range 2 East, thence run West along the South line of said quarter-quarter section a distance of 356.27 feet; thence turn an angle of 68 degrees, 39 minutes, 10 seconds to the right and run a distance of 713.02 feet to the North line of the South ½ of the South ½ of said Northeast ¼; thence turn an angle of 111 degrees, 20 minutes, 20 seconds to the right and run along the North line of said South ½, South ½, Northeast ¼, a distance of 655.94 feet to the West right of way of the Central of Georgia Railroad; thence turn an angle of 68 degrees, 40 minutes, 30 seconds to the right and run along said right of way a distance of 712.94 feet to the South line of the Southeast ¼ of the Northeast ¼ of said section; thence turn an angle of 111 degrees, 20 minutes to the right and run a distance of 299.67 feet to the point of beginning. All of said property being situated in the South ½ of the Southwest ¼ of the Northeast ¼ and the South ½ of the Southeast ¼ of the Northeast ¼ in Section 23, Township 19 South, Range 2 East, Huntsville Meridian, in Shelby County, Alabama.
