KNOW ALL MEN BY THESE PRESENTS

THAT, WHEREAS, heretofore, on to-wit, August 3, 1998, Rebecca Isbell, an unmarried woman and Anthony Howard, an unmarried man, executed a certain mortgage on property hereinafter described to Green Tree Servicing LLC successor servicer to Bank of America, FSB, which said mortgage is recorded in Instrument # 1998-29553 in the Office of the Probate Judge in Shelby County, Alabama; and


WHEREAS, in and by said mortgage, the mortgagee, its successors or assigns, was authorized and empowered in the event of default, according to the terms thereof, to sell said property before the Courthouse door in the City of Columbiana, Shelby County, Alabama, after giving notice of the time, place and terms of said sale in some newspaper published in said County by publication once a week for three (3) consecutive weeks prior to said sale at public outcry for cash, to the highest bidder, and said mortgage provided that in case of sale under the power and authority contained in same, the mortgagee or any person conducting said sale for the mortgagee was authorized to execute the proper conveyance to the purchaser at said sale; and it was further provided in and by said mortgage that the mortgagee may bid at the sale and purchase said property if the highest bidder therefor; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the same Green Tree Servicing LLC, did declare all of the indebtedness secured by said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of foreclosure of said mortgage, by U. S. Mail and by publication in *Shelby County Reporter* newspaper of general circulation, published in Shelby County, Alabama, in its issues of the June 28, July 5 and July 12, 2006;

WHEREAS, on the 19th day of July, 2006, the day on which said foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Nathan A. Wake as Attorney-in-Fact for the said Green Tree Servicing LLC did offer for sale and sell at public outcry, at the Courthouse in Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Nathan A. Wake was the Auctioneer who conducted said foreclosure sale for the said Green Tree Servicing LLC; and

WHEREAS, the said Green Tree Servicing LLC was the highest bidder in the amount of



Seventy Three Thousand Seven Hundred Sixty and 41/100 Dollars (\$73,760.41), which sum of money Green Tree Servicing LLC offered to apply to the costs of foreclosure and credit the remaining balance on the indebtedness secured by said mortgage, and said property was thereupon sold to Green Tree Servicing LLC.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES, and of a credit in the amount of Seventy Three Thousand Seven Hundred Sixty and 41/100 Dollars (\$73,760.41), on the indebtedness secured by said mortgage, the said Rebecca Isbell and Anthony Howard to Green Tree Servicing LLC by and through Nathan A. Point being on the East right of way line of County Highway # 50; thence continue along the last named course 544.76 feet; thence 90°00′ to the left 199.85 feet; thence 96°56′21″ to the left 550.31 feet to the East right of way line of County Highway # 50; thence 83°42′54″ to the left along said right of way line 133.38 feet to the point of beginning.
