## CSX CROSSING

A 40 foot utility easement for a water line situated in the, Shelby County Alabama, being more particularly described as follows:

Commence at the NE corner of Section 20, Township 20 South, Range 2 West, thence run in a Southerly direction along the East line of said Section to the point of intersection with the Northwest right of way line of the CSX Railroad, thence turn an angle to the right and run in a Southwesterly direction along the said Northwest right of way line to the point of intersection with a point on the Northwest right of way line of said CSX Railroad perpendicular to Milepost ANJ-954.909, also said point being the Point of Beginning of the 40 foot easement herein described, thence turn an angle of 90° to the left and run in a Southeasterly direction 100 feet across said CSX Railroad right of way to the point of intersection with the Southeast right of way line of said CSX Railroad at Milepost ANJ-954.909, thence turn an angle to the right of 90° and run in a Southwesterly direction along the said Southeast right of way line 40 feet to a point on the said Southeast right of way line at Milepost ANJ-954.916, thence turn an angle of 90° to the right and run in a Northwesterly direction 100 feet to a point on the Northwest right of way line of said CSX Railroad at Milepost ANJ-954.916, thence turn an angle of 90° to the right and run in a Northeasterly direction along the said Northwest right of way line of said CSX Railroad 40 feet to the Point of Beginning of the 40 foot easement herein described. Said easement contains 0.092 acres more or less, and the alignment and orientation is shown on the attached Exhibit A.
