KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **One Hundred Fifty Nine Thousand Nine Hundred dollars and Zero cents** (**\$159,900.00**) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Marcie Terry Meserole f/n/a Marcie Lee Terry and husband Anthony P. Meserole** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **William H. Palmer, III and Jean Palmer as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

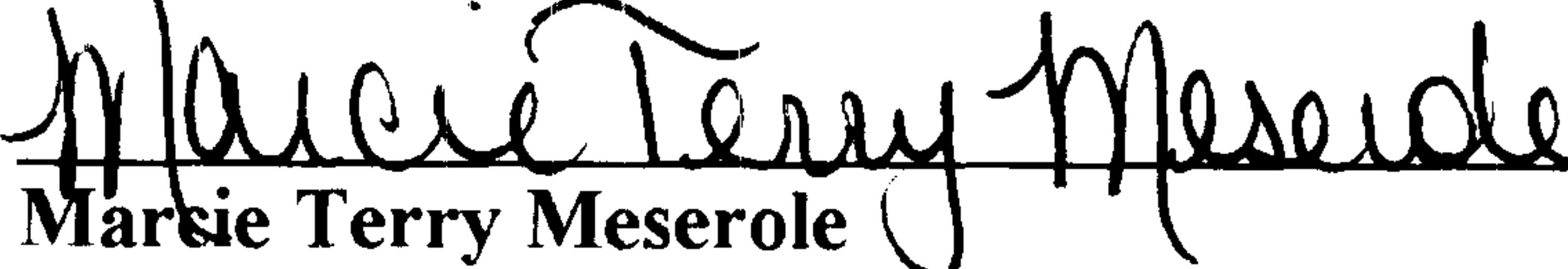
Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

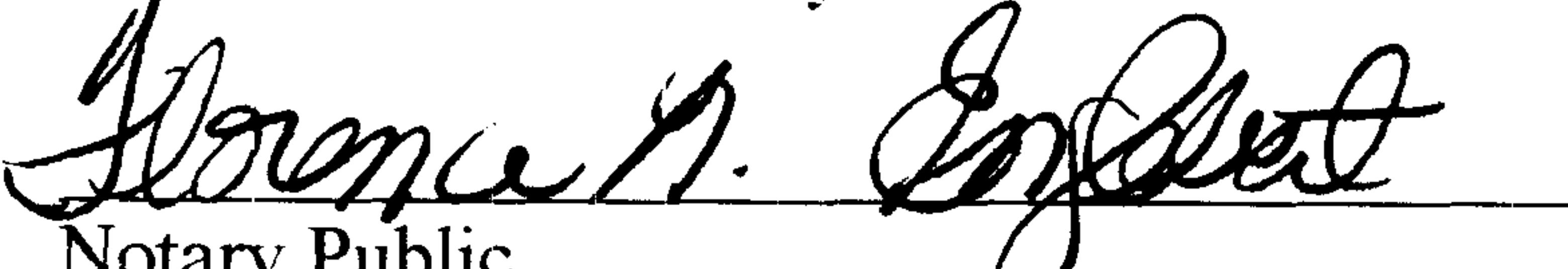
