

ARTICLES OF ORGANIZATION OF LEDBETTER ERECTION, LLC

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Ledbetter Erection, LLC (the "Company").

ARTICLE II

Duration

Unless it is dissolved and its affairs wound up as provided in the Operating Agreement or as may be required by the Act, the Company shall have perpetual duration and succession in its name beginning on the date these Articles are filed with the Judge of Probate.

ARTICLE III

Purposes

The purposes for which the Company is formed are:

- (a) To engage in the business of acquiring, owning, developing, improving, operating, leasing, selling and otherwise dealing in and with improved and unimproved real property directly and indirectly, including industrial construction.
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.


ARTICLE IV
