

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of \$114,050.00 to the undersigned grantor, **TOWER DEVELOPMENT, INC.**, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant. bargain, sell and convey unto **JOEY L.
