

## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Nineteen Thousand and no/100 Dollars (\$119,000.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged J. KEVIN ALLRED and wife, HOLLY N. ALLRED (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto STEFANIE DIANE BURNETTE and DELORES BURNETTE (herein referred to as "Grantees"), as joint tenants with rights of survivorship, his interest in the following described real estate situated in Shelby County, Alabama, to wit:

Lot 55 according to the Map and Survey of Wyndham Cottages, Phase 1, as recorded in Map Book 25, Page 14, in the Office of the Judge of Probate of Shelby County, Alabama.

AND THE GRANTOR does for their heirs and executors, successors and assigns, covenant with said Grantees, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and their heirs and executors, successors and assigns shall warrant and defend same to said Grantees, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.
