## POWER OF ATTORNEY



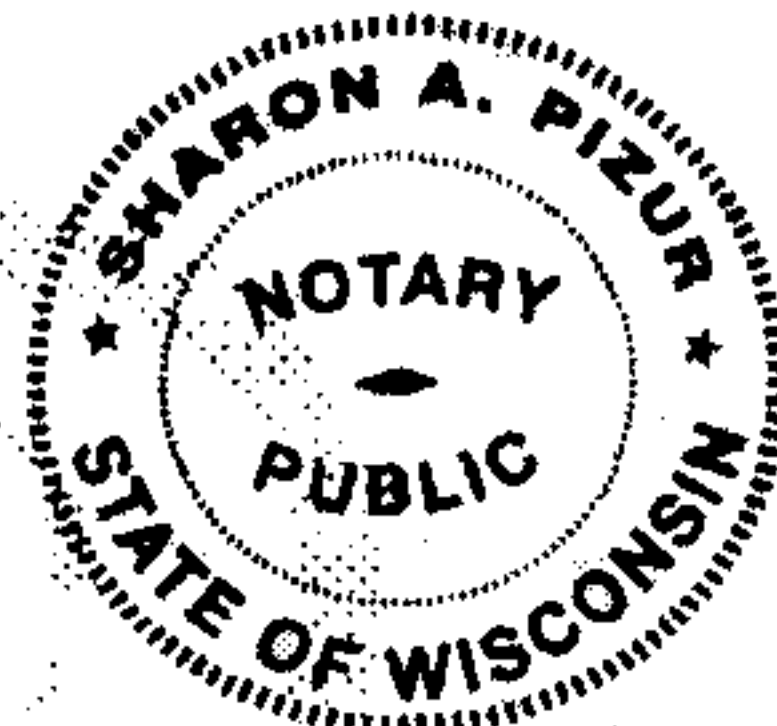



