

ARTICLES OF ORGANIZATION

OF

SAENZ DRYWALL, LLC.

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the Act), hereby adopt the following Articles of Organization for Saenz Drywall, LLC.

ARTICLE ONE

The name of the Company is Saenz Drywall, LLC.

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The Company is organized for the purpose of conducting the business of Drywall preparation, installation, finishing in both commercial and residential construction.

ARTICLE FOUR

The mailing address of the initial registered office is 128 Blue Spring Place, Alabaster, Alabama 35007 and the name of the initial registered agent of the Company at such address is Monica Saenz.

ARTICLE FIVE

ARTICLE SIX

The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be mutually agreed by the Company and the additional members.

ARTICLE SEVEN

The legal existence and business of the Company may be continued by the written consent of all the remaining members within 90 days after an event of dissociation of a member.
