Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

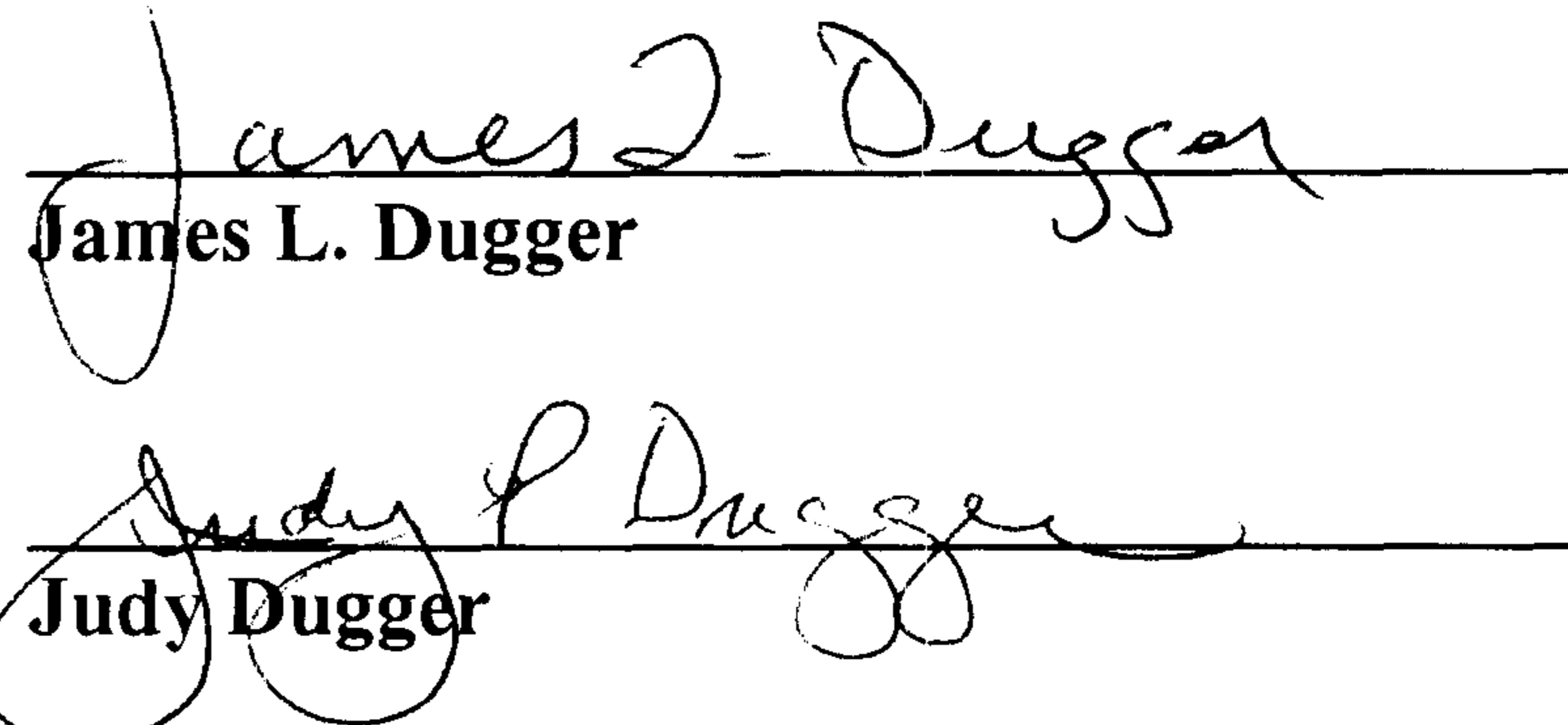

EXHIBIT "A" LEGAL DESCRIPTION

Lot 3, according to map of Sunny Brook Subdivision, as recorded in Map Book 6, Page 61 and 64, in the Probate Office of Shelby County, Alabama, also the following: Begin at the Southeast corner of Lot 3, Map of Sunny Subdivision; thence in a Westerly direction along the South boundary of said Lot 3 a distance of 235 feet to a Southwest corner; therefore thence, turn 90 degrees, 00' to the left in a Southerly direction 80.00 feet; thence 90 degrees 00' to the left in an Easterly direction 235.00 feet; thence 90 degrees 00' to the left in a Northerly direction 80.00 feet to the point of beginning.
