THAT the United States of America, acting by and through the Farmers Home Administration, United States Department of Agriculture, for and in consideration of the sum of Forty Five Thousand and No/100 Dollars, (\$45,000.00), the receipt whereof is hereby acknowledged, does hereby remise, release, quitclaim and convey unto John D. Boyd and wife, Lisa A. Boyd, as joint tenants with the right of survivorship, all its rights, title, claim, interest, equity and estate in and to the following described lands lying in the County of Shelby, State of Alabama, to-wit:

Lot 16 and 17, Block 1, Wilmont Gardens, as recorded in Map Book 4, Page 6, in the Office of the Judge of Probate in Shelby County, Alabama.

SUBJECT TO: Redemption Rights in accordance with Section 6-5-230, Code of Alabama, which redemption rights expire on July 16, 1993.

Subject, however, to all easements and rights-of-way upon, across or through the above-described lands as heretofore have been granted by the United States of America or its predecessors in title.

TO HAVE AND TO HOLD the same unto the said grantees and, upon the death of either of them, then to the survivor, and to the heirs and assigns of such survivor, in fee simple, forever.
