MORTGAGE MODIFICATION AGREEMENT



THIS MORTGAGE MODIFICATION AGREEMENT is made and entered into on this the **18TH** day of **AUGUST 2006** by and between **JEFFERY LYNN ELLIOTT AND WIFE SHERRY M ELLIOTT**, (hereinafter referred to as the "Mortgagors") and **CENTRAL STATE BANK**, (hereinafter called the "Mortgagee").






