

A parcel of land situated in the South ½ of the Southeast ¼ of Section 1, Township 21 South, Range 3 West, Shelby County, Alabama being more particularly described as follows:


Commence at the Southeast corner of Section 1, Township 21 South, Range 3 West and run in a Westerly direction along the South line of said Section 1 a distance of 1369.37 feet to a point on the Westerly right-of-way line of a proposed road, said point also being the POINT OF BEGINNING of the parcel described herein; thence continuing along the last described course a distance of 595.99 feet to a point on the Easterly right-of-way line of Colonial Promenade Parkway as shown on the Final Plat of Colonial Promenade Alabaster Survey as recorded in Map Book 35, Page 102 A & B in the Office of the Judge of Probate, Shelby County, Alabama; thence 84 degrees 15 minutes 29 seconds to the right in a Northerly direction along said Easterly right-of-way line of Colonial Promenade Parkway a distance of 428.78 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 25.00 feet and a central angle of 86 degrees 31 minutes 11 seconds; thence along the arc of said curve in a Northerly, Northeasterly and Easterly direction (leaving said Easterly right-of-way line of Colonial Promenade Parkway) a distance of 37.75 feet to the P.T. (Point of Tangent) of said curve, said point lying on the Southerly right-of-way line of Jimmy Gould Drive as shown on the Final Plat of Colonial Promenade Alabaster Survey; thence tangent to said curve in an Easterly direction and along said Southerly right-of-way line of Jimmy Gould Drive a distance of 491.10 feet to a point, said point being the Southeasterly corner of said Jimmy Gould Drive as shown on the Final Plat of Colonial Promenade Alabaster Survey; thence continuing along the last described course (leaving said Jimmy Gould Drive) and along the extension of the Southerly right-of-way line of Jimmy Gould Drive a distance of 1.39 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 175.00 feet and a central angle of 17 degrees 14 minutes 19 seconds; thence along the arc of said curve in an Easterly direction and along said extension of the Southerly right-of-way line of Jimmy Gould Drive a distance of 52.65 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in an Easterly direction and along said extension of the Southerly right-of-way line of Jimmy Gould Drive a distance of 93.26 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 25.00 feet and a central angle of 86 degrees 33 minutes 37 seconds; thence along the arc of said curve in an Easterly, Southeasterly and Southerly direction a distance of 37.77 feet to the P.R.C. (Point of Reverse Curve) of a curve to the left having a radius of 875.00 feet and a central angle of 8 degrees 57 minutes 27 seconds, said point lying on the Westerly right-of-way line of a proposed through road; thence along the arc of said curve in a Southerly direction (leaving said extension of Jimmy Gould Drive) and along said Westerly right-of-way line of a proposed through road a distance of 136.80 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Southerly direction along said Westerly rightof-way line of a proposed through road a distance of 140.49 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 400.00 feet and a central angle of 32 degrees 07 minutes 48 seconds; thence along the arc of said curve in a Southerly and Southwesterly direction and along said Westerly right-of-way line of a proposed through road a distance of 224.31 feet to the POINT OF BEGINNING.

A parcel of land situated in the Southeast ¼ of Section 1, Township 21 South, Range 3 West, Shelby County, Alabama being more particularly described as follows:

Commence at the Southeast corner of Section 1, Township 21 South, Range 3 West and run in a Westerly direction along the South line of said Section 1 a distance of 1369.37 feet to a point on the Westerly right of way line of a proposed road, said point lying on a curve to the left having a radius of 400.00 feet and a central angle of 32 degrees, 07 minutes, 48 seconds; thence in a Northeasterly and Northerly direction along the arc of said curve and along said Westerly right of way line of a proposed through road a distance of 224.31 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Northerly direction along said Westerly right of way line of a proposed through road a distance of 140.49 to the P.C. (Point of Curve) of a curve to the right having a radius of 875.00 feet and a central angle of 15 degrees, 57 minutes, 53 seconds; thence in a Northerly and Northeasterly direction along the arc of said curve and along said Westerly right of way line of a proposed through road a distance of 243.81 feet to a point on a curve to the right having a radius of 25.00 feet and a central angle of 86 degrees, 25 minutes, 57 seconds, said point being the point of beginning of the parcel herein described; thence 180 degrees, 00 minute, 00 second to the right (angle measured from tangent) in a Southwesterly and Westerly direction (leaving said Westerly right of way line of a proposed through road) along the arc of said curve a distance of 37.71 feet to the P.T. (Point of Tangent) of said curve, said point lying on the Northerly right of way line of the extension of Jimmy Gould Drive; thence tangent to said curve in a Westerly direction along said Northerly right of way line of the extension of Jimmy Gould Drive a distance of 93.38 feet to the P.C. of a curve to the left having a radius of 235.00 feet and a central angle of 17 degrees, 14 minutes, 19 seconds; thence in a Westerly direction along the arc of said curve and along said Northerly right of way line of the extension of Jimmy Gould Drive a distance of 70.70 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Westerly direction along said Northerly right of way line of the extension of Jimmy Gould Drive a distance of 5.29 feet to a point, said point being the Northeasterly corner of Jimmy Gould Drive and the Southeasterly corner of Lot 3 as shown on the Final Plat of Colonial Promenade Alabaster Survey as recorded in Map Book 35, Page 102 A & B in the Office of the Judge of Probate of Shelby County, Alabama; thence 86 degrees, 17 minutes, 09 seconds to the right in a Northerly direction (leaving said right of way line of Jimmy Gould Drive) along the Easterly line of Lot 3 of said Colonial Promenade Alabaster Survey a distance of 518.30 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 55.00 feet and a central angle of 48 degrees, 14 minutes, 23 seconds; thence in a Northerly and Northeasterly direction along the arc of said curve and along said Easterly line of Lot 3 a distance of 46.31 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Northeasterly direction along said Easterly line of Lot 3 a distance of 20.06 feet to the P.C. (Point of Curve) of a curve to the left having a radius of 65.00 feet and a central angle of 43 degrees, 14 minutes, 23 seconds; thence in a Northeasterly and Northerly direction along the arc of said curve and along said Easterly line of Lot 3 a distance of 49.05 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Northerly direction along said Easterly line of Lot 3 a distance of 320.64 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 60.00 feet and a central angle of 50 degrees, 38 minutes, 01 seconds; thence in a Northerly and Northeasterly direction along the arc of said curve and along said Easterly line of Lot 3 a distance of 53.02 to the P.R.C. (Point of Reverse Curve) of a curve to the left having a radius of 70.00 feet and a central angle of 96 degrees, 14 minutes, 51 seconds; thence in a Northeasterly, Northerly and Northwesterly direction along the arc of said curve and along said Easterly line of Lot 3 a distance of 117.59 feet to the P.R.C. (Point of Reverse Curve) of a curve to the right having a radius of 60.00 feet and a central angle of 70 degrees, 36 minutes, 50 seconds; thence in a Northwesterly and Northerly direction along the arc of said curve and along said Easterly line of Lot 3 a distance of 73.95 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Northerly direction along said Easterly line of Lot 3 a distance of 111.29 to a point, said point being the Northeasterly corner of Lot 3 and lying on the Southwesterly right of way line of Progress Boulevard of said Colonial Promenade Alabaster Survey; thence 95 degrees, 00 minutes to the right in a Southeasterly direction (leaving said Easterly line of Lot 3) along said Southwesterly right of way line of Progress Boulevard a distance of 196.66 feet to the Southeasterly corner of said Progress Boulevard; thence continuing



along the last described course and along the extension of Progress Boulevard a distance of 754.30 feet to the P.C. (Point of Curve) of a curve to the right having a radius of 25.00 feet and a central angle of 95 degrees, 46 minutes, 22 seconds; thence in a Southeasterly, Southerly and Southwesterly direction along the arc of said curve a distance of 41.79 feet to the P.C.C. (Point of Compound Curve) of a curve to the right having a radius of 900.00 feet and a central angle of 16 degrees, 06 minutes, 50 seconds, said point lying on the Northwesterly right of way line of a proposed through road; thence in a Southwesterly direction (leaving said extension of Progress Boulevard) along the arc of said curve and along said Northwesterly right of way line of a proposed through road a distance of 253.12 feet to the P.T. (Point of Tangent) of said curve; thence tangent to said curve in a Southwesterly direction along said Northwesterly right of way line of a proposed through road a distance of 303.37 to the P.C. (Point of Curve) of a curve to the left having a radius of 875.00 feet and a central angle of 32 degrees, 21 minutes, 59 seconds; thence in a Southwesterly and Southerly direction along the arc of said curve and along said Northwesterly right of way line of a proposed through road a distance of 494.93 feet to the point of beginning.
