POWER OF ATTORNEY

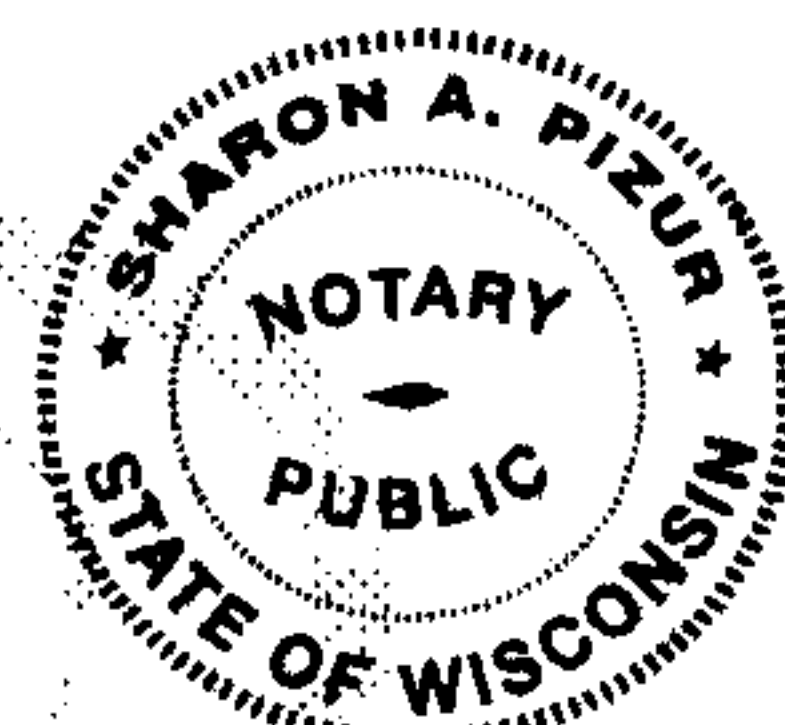
