THENTY THOUSAND (\$ عور مور) to <u>M</u>وin hand paid by Alabama Power Company, a corporation, (hereinafter known as Grantee), the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission and communication lines and all towers, poles, conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other appliances necessary or convenient in connection therewith from time to time over, under and across, a strip of land varying in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over, under and across the lands of which it is hereinafter described as being a part, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and undergrowth and all other obstructions under, on or above said strip and the right to cut such timber outside of said strip which in falling would come within five (5) feet of any conductor on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip, and the right to install grounding devices on grantors' fences now or hereafter located on such strip and on fences or other structures of grantors now or hereafter located adjacent to such strip, and the right to prevent the use of such strip as a parking area for automobiles or other vehicles, as a storage area for machinery or materials, or as a road other than a road crossing such strip at a location which does not endanger or interfere with works that have been or may at some future date be constructed on such strip, said strip and the lands of which the same is a part being described as follows:

A strip of land varying in width which lies within the Southeast Quarter of the Northwest Quarter (SE¼ of NW¼) and the Northeast Quarter of the Southwest Quarter (NE¼ of SW¼) of Section 16, Township 20 South, Range 02 West, Shelby County, Alabama, such strip being more particularly described as follows:

To reach the point of beginning, commence at the Northeast Corner of Section 16, Township 20 South, Range 02 West; thence run S57°31'50"W a distance of 663.34 feet to a point; thence turn a deflection angle to the left and run S31°48'12"W a distance of 273.91 feet to a point; thence turn a deflection angle to the right of 06°17'46" and run S38°05'58"W a distance of 487.95 feet to a point; thence turn a deflection angle to the right of 05°34'08" and run S43°40'06"W a distance of 1016.96 feet to a point; thence turn a deflection angle to the right of 03°57'53" and run S47°37'59"W a distance of 459.74 feet to a point; thence turn a defection angle to the right of 09°08'06" and run S56°46'05"W a distance of 410.40 feet to a point; thence turn a defection angle to the right of 03°55'48" and run S60°41'53"W a distance of 251.77 feet to a point, such point being the point of beginning of the right of way herein described; therefrom, the strip is varying in width and lies up to road right of way right of and 20 feet left of a survey line and the continuations thereof which begins at such point of beginning and continues S60°41'53"W a distance of 799 feet, more or less, to a point, such point being the point of ending of the right of way herein described.

The grantors covenant with the said Grantee, that they are lawfully seized in fee of the above described land; that it is free from all encumbrance; that they have a good right to convey the same to the said Company, and that they will warrant and defend the said land to the said Company forever.

TO HAVE AND TO HOLD the same to the said Grantee, its successors and assigns, forever.

The grantors shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.
