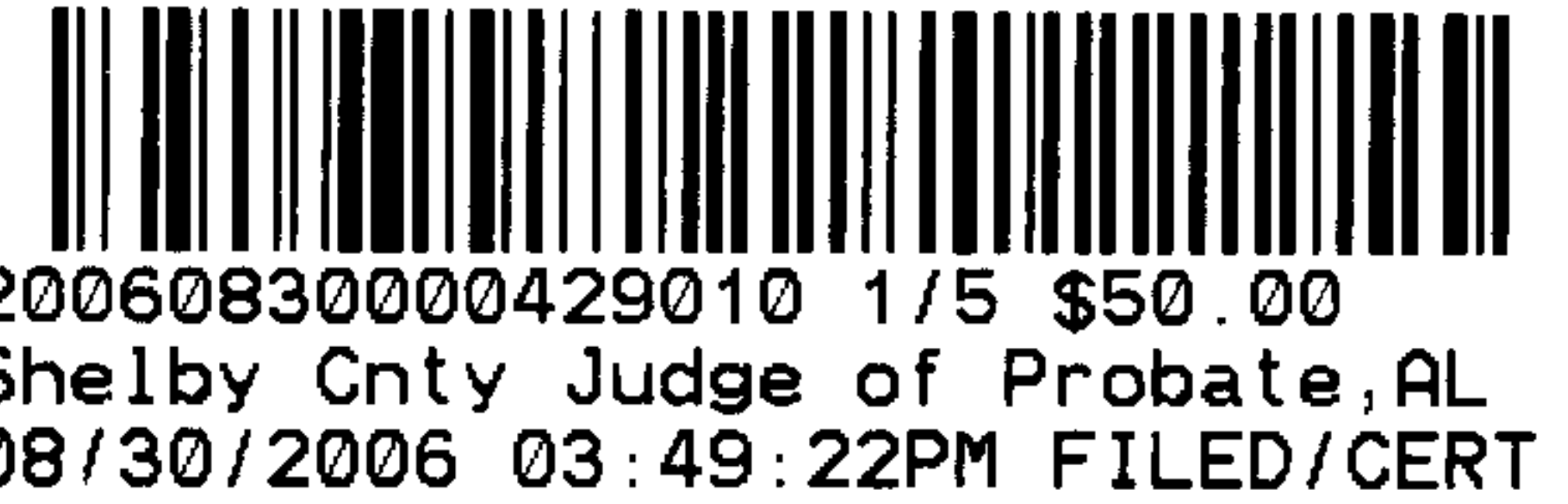

**ARTICLES OF INCORPORATION
