

## WARRANTY DEED

## Joint Tenants With Right of Survivorship



STATE OF ALABAMA	}	KNOW ALL MEN BY THESE PRESENTS:
COUNTY OF SHELBY	}	

That in consideration of the sum of **One Hundred Twenty-nine Thousand Nine Hundred and 00/100 Dollars** (\$129,900.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, We,

## Charles R. Barger and Staci R. Barger, husband and wife

(herein referred to as GRANTORS) do grant, bargain, sell and convey unto

## Sandra D. Gardner and Jeremy Gardner

(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 253, according to the Survey of Final Plat Camden Cove, Sector 8, as recorded in Map Book 31, page 64, in the Probate Office of Shelby County, Alabama.

Subject to:

- (1) 2006 ad valorem taxes not yet due and payable;
- (2) all mineral mining rights not owned by the Grantors; and
- (3) all easements, rights-of-way, restrictions covenants and encumbrances of record.

\$129,900.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.

TO HAVE AND TO HOLD Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
