My name is David Lowery and I am over the age of 21 years, and am familiar with the following facts:

Edgar Frost and Lizzie Julia Jane Frost a/k/a Lizzie Lowery Frost were the owners of the following described property, to-wit:

PARCEL 1:

The NW ¼ of SW ¼, except the SE ¼ of the NW ¼ of the SW ¼; W ½ of SW ¼ of SW ¼, except the SW ¼ of the SW ¼ of the SW ¼, Section 13, Township 22 South, Range 3 West, Shelby County, Alabama.
The E ½ of SE ¼, Section 14, Township 22 South, Range 3 West, Shelby County, Alabama.

Edgar Frost and Lizzie Julia Jane Frost purchased this property in 1965, as shown by deed recorded in Deed Book 235, Page 198, in the Probate Office of Shelby County, Alabama. Edgar Frost died on or about the 20th day of March, 1968, leaving Lizzie Julia Jane Frost as the surviving grantee.

Lizzie Lowery Frost was the owner of the following described property, to-wit:

NW ¼ of NW ¼ of SE ¼ of Section 13, Township 22 South, Range 3 West, in Shelby County, Alabama.




