




EXHIBIT A

A parcel of land in the NE ¼ of the NE ¼ of Section 18, Township 21 South, Range 2 East, more particularly described as follows:

Commence at the NE corner of Section 18, Township 21 South, Range 2 East, Shelby County, Alabama; thence South 89 degrees 49 minutes 36 seconds West a distance of 733.34 feet to the point of beginning; thence North 89 degrees 59 minutes 46 seconds West a distance of 314.29 feet; thence South 1 degree 30 minutes 48 seconds West a distance of 307.43 feet to the northwesterly right of way of Hebb Road and a point on a curve to the left having a central angle of 06 degrees 39 minutes 37 seconds and a radius of 3833.80 feet, said curve subtended by a chord bearing North 46 degrees 22 minutes 28 seconds East and a chord distance of 445.40 feet; thence along the arc of said curve and along said right of way a distance of 445.66 feet to the point of beginning; being situated in Shelby County, Alabama.
