
ARTICLES OF ORGANIZATION OF MOVING ON UP INVESTMENTS, LLC



Pursuant to the Provisions of Act No. 93-274 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I THE NAME OF THE LIMITED LIABILITY COMPANY IS:

ARTICLE II DURATION

The period of the duration is perpetual.

ARTICLE III PURPOSES

The purchase, sales, rentals, leasing, building and investments of residential and commercial property, including but not limited to renovations, pre-sales, speculative investments with residential, agricultural and commercial property. This LLC shall not be limited to this sole purpose.
