






EXHIBIT "A"

A parcel of land situated in the SW ¼ of the SW ¼ of the NW ¼ of Section 31, Township 18 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows: Begin at an iron pin found locally accepted to be the SE corner of said 1/4 1/4 1/4 section; thence run in a westerly direction along the South line of said % % % section for a distance of 351.52 feet to an iron pin set; thence turn an angle to the right of 80 deg. 37 min. 39 sec. and run in a northerly direction for a distance of 210.00 feet to an iron pin set; thence turn an angle to the left of 89 deg. 41 min. 20 sec. and run in a westerly direction for a distance of 241.79 feet to an iron pin set; thence turn an angle to the right of 75 deg. 42 min. 38 sec, and run in a northwesterly direction for a distance of 79.32 feet to an iron pin set; thence turn an angle to the left of 13 deg. 53 min. 29 sec. and run in a northwesterly direction for a distance of 60.44 feet to an iron pin set; thence turn an angle to the left of 62 deg. 07 min. 49 sec. and run in a westerly direction for a distance of 25.80 feet to an iron pin set on the West line of said 1/2 1/2 section; thence turn an angle to the right of 90 deg. 23 min. 09 sec. and run in a northerly direction along the West line of said 1/4 1/4 section for a distance of 123.29 feet to an iron pin found, said iron pin found being on the Southeast right of way line of Cahaba Beach Road; said iron pin found also being on a curve to the right having a central angle of 15 deg. 04 min. 15 sec. and a radius of 748.25 feet; thence turn an angle to the right of 42 deg. 06 min. 10 sec. to the chord of said curve and run in a northeasterly direction along the arc of said curve and also along the Southeast right of way line of said Cahaba Beach Road for a distance of 196.82 feet to an iron pin set; thence run tangent to last stated curve in a northeasterly direction along the Southeast right of way line of said Cahaba Beach Road for a distance of 82.46 feet to an iron pin set; thence turn an angle to the right of 79 deg. 52 min. 41 sec. and run in a southeasterly direction for a distance of 176.34 feet to an iron pin found; thence turn an angle to the right of 89 deg. 27 min. 19 sec. and run in a southwesterly direction for a distance of 43.27 feet to an iron pin set; thence turn an angle to the left of 118 deg. 38 min. 21 sec. and run in a southeasterly direction for a distance of 116.17 feet to an iron pin found; thence turn an angle to the right of 79 deg. 00 min. 11 sec. and run in a southerly direction for a distance of 175.02 feet to an iron pin found; thence turn an angle to the left of 79 deg. 00 min. 11 sec. and run in a southeasterly direction for a distance of 249.97 feet to an iron pin found, said iron pin found being on the East line of said 1/2 1/2/4 section; thence turn an angle to the right of 78 deg. 38 min. 22 sec. and run in a southerly direction along the East line of said 1/4 1/4 1/4 section for a distance of 275.30 feet to the point of beginning.
