STATUTORY WARRANTY DEED

KNOW ALL PERSONS BY THESE PRESENTS, that in consideration of ONE HUNDRED SIXTY SIX THOUSAND NINE HUNDRED AND NO/100 Dollars (\$166,900.00) to the undersigned Holland Lakes, Inc., an Alabama corporation ("Grantor"), in hand paid by CREEL RICHARDSON, III ("Grantee"), the receipt and sufficiency of which are hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Grantee the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 251, according to the Final Plat of Holland Lakes, Sector Two, Phase Two, as recorded in Map Book 36, Page 55 in the Probate Office of Shelby County, Alabama (the "Property").

Together with the nonexclusive easement to use the Common Areas as more particularly described in Holland Lakes Declaration of Covenants, Conditions, and Restrictions executed by the Grantor and filed for record as Instrument No. 20050425000196100 in the Probate Office of Shelby County, Alabama (the "Declaration").

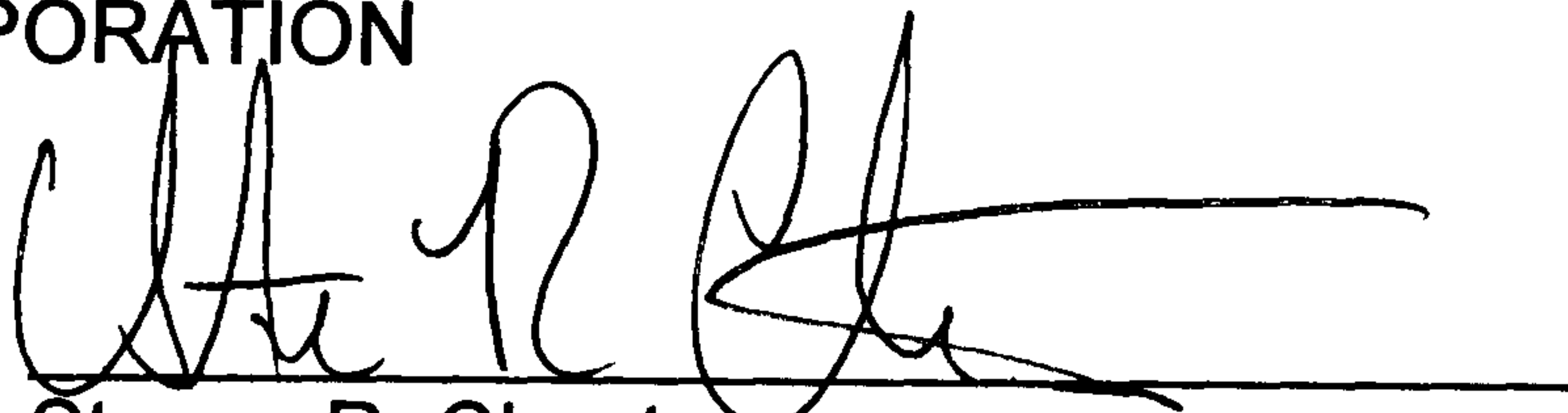
