issuance of Payment, Performance or Bid bonds.

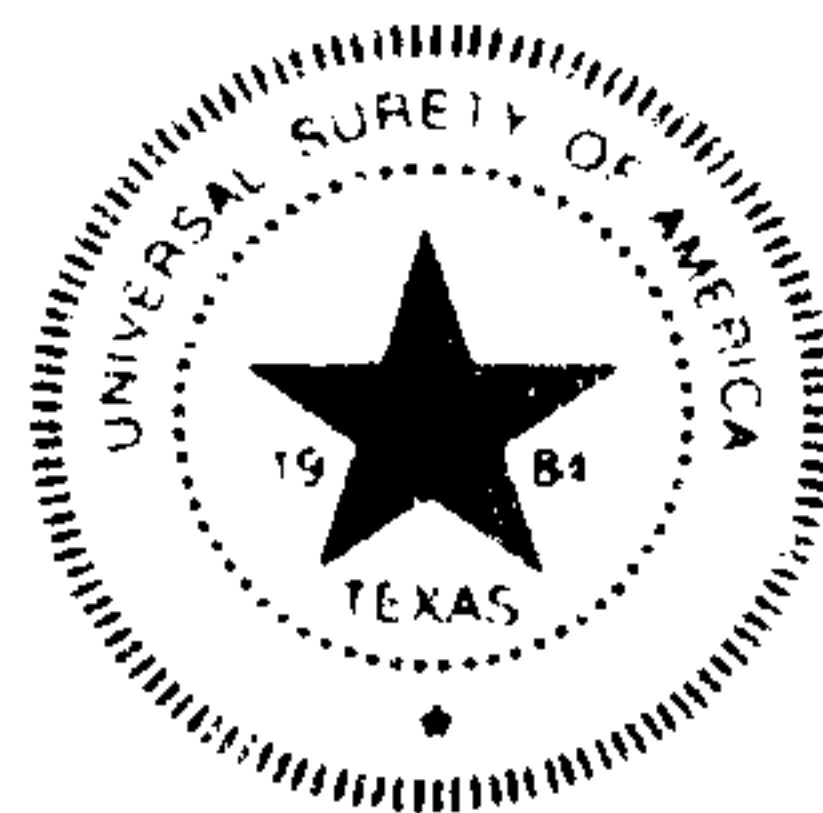

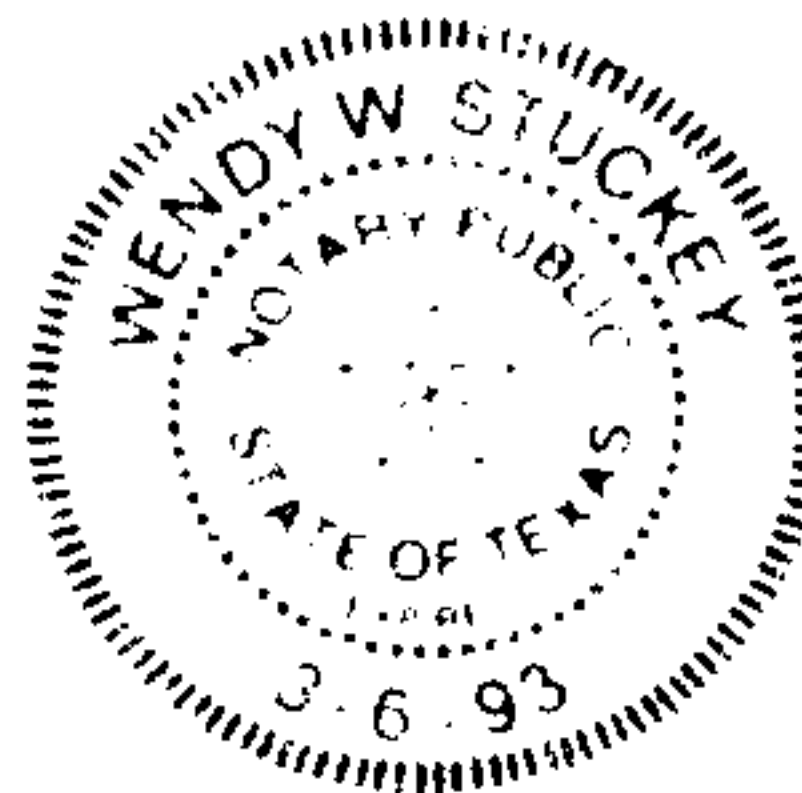

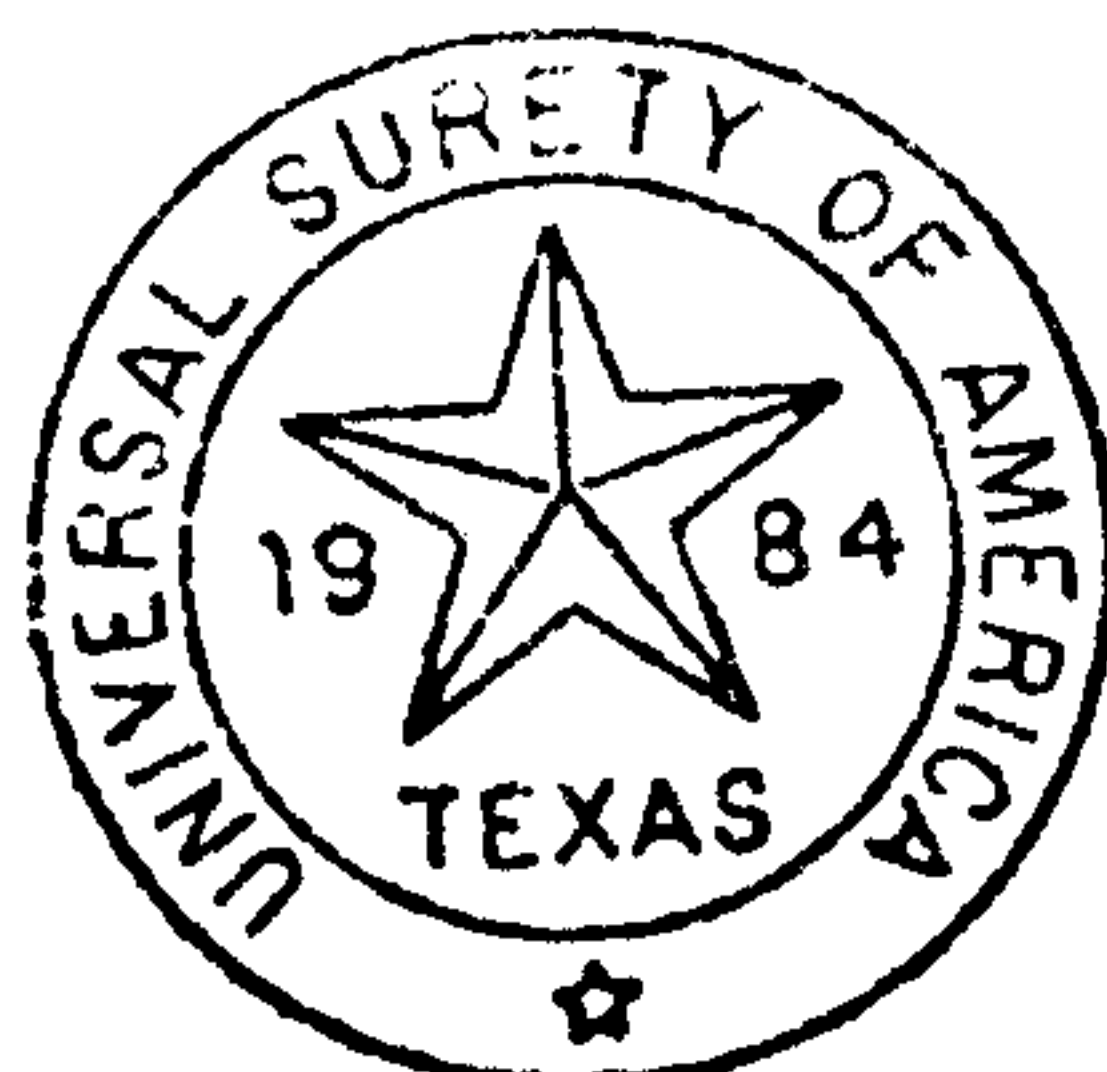
