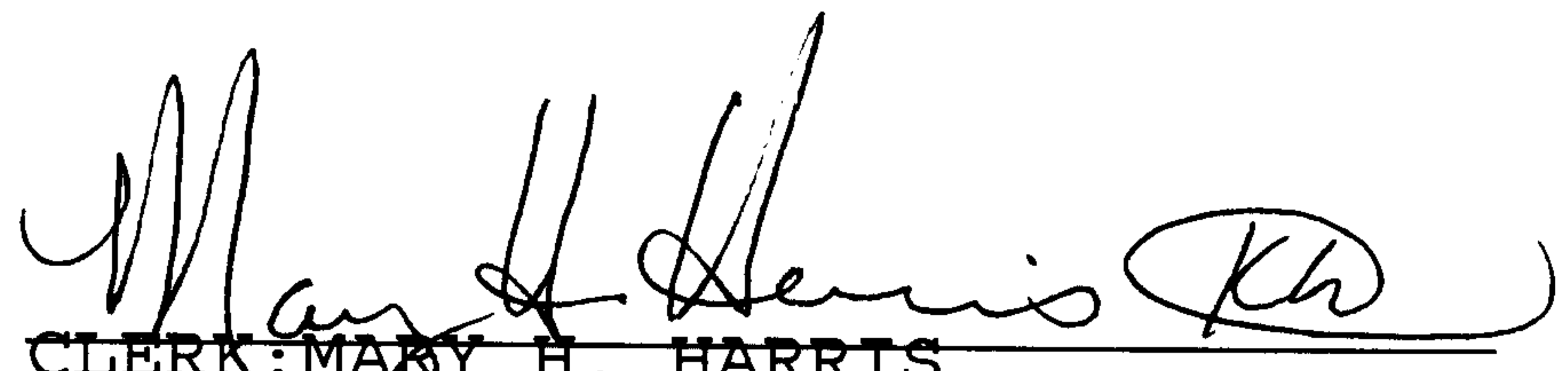

DEFAULT JUDGMENT

On June 23, 2006, Plaintiff International Business Machines Corporation ("IBM" or "Plaintiff") filed an Application for Entry of Default against Defendant US Certified Letters, LLC ("US Certified" or "Defendant") for failure to plead, answer, or otherwise defend as to IBM's Complaint on Promissory Note. This Court rules that IBM's Application for Entry of Default, supported with a Notice of Filing Affidavits in Further Support of Default Judgment served on July 18, 2006, is **GRANTED**, and **DEFAULT JUDGMENT** in favor of IBM and against Defendant is **ENTERED**. Thus, it is **ORDERED, ADJUDGED, AND DECREED** that Plaintiff shall have and recover from Defendant the sum of \$ 91,050.56, computed as follows:

\$ 8,982.50	Attorneys' Fees
\$ 540.54	Costs
