KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Five Hundred Thirty Five Thousand dollars and Zero cents (\$535,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Selwyn M. Vickers and wife Janice F. Vickers (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto J. Paul Correia and Lindsey N. Correia as joint tenants with rights of survivorship (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama:

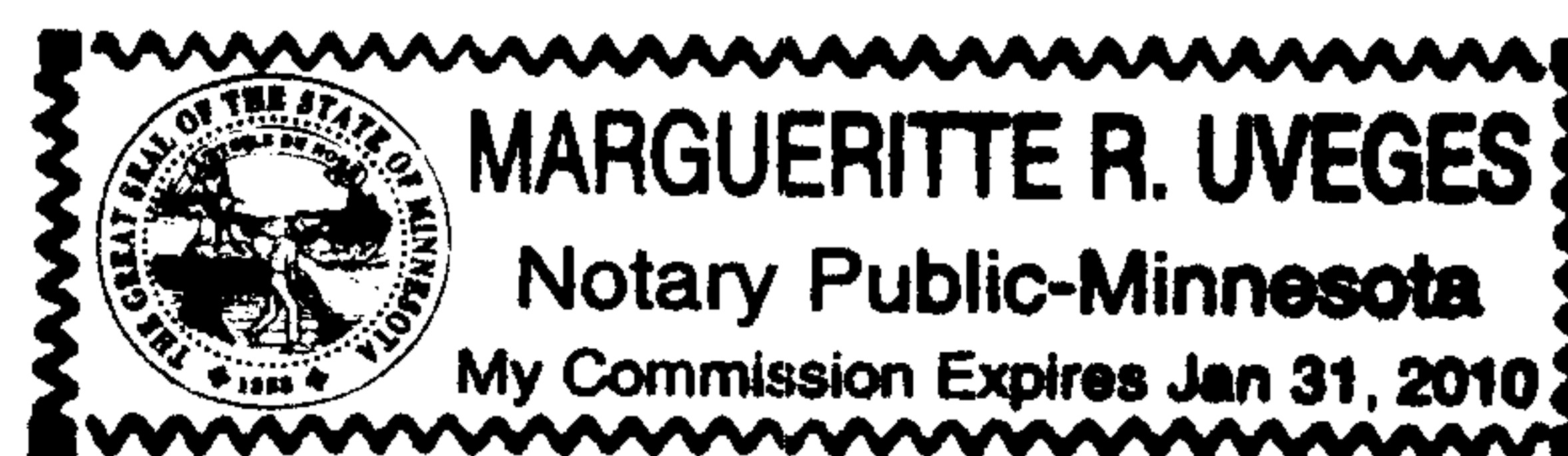
