KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of October 2004, Greg Armstrong and Betty Armstrong, husband and wife, executed that certain mortgage on real property hereinafter described to Argent Mortgage Company, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20041101000600370, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank N.A., as Trustee; and


