DESCRIPTION OF REAL PROPERTY

Parcel 1

Commence at the NW corner of the SW 1/4 of the NE 1/4 of said Section 36, and run thence South 88 deg. 15 min. 29 sec. East along the northerly line of the SW 1/4 of the NE 1/4 of said Section 36 for a distance of 179.93 feet; thence leaving said northerly line South 01 deg. 44 min. 02 sec. West for a distance of 169.47 feet to the point of beginning of the parcel herein described; thence South 79 deg. 32 min. 29 sec. East for a distance of 179.18 feet; thence South 18 deg. 35 min. 30 sec.
