

## KNOW ALL MEN BY THESE PRESENTS, THAT

Whereas, on the 7<sup>th</sup> day of April, 2003, a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **Sylvester M. and Barbara J.
