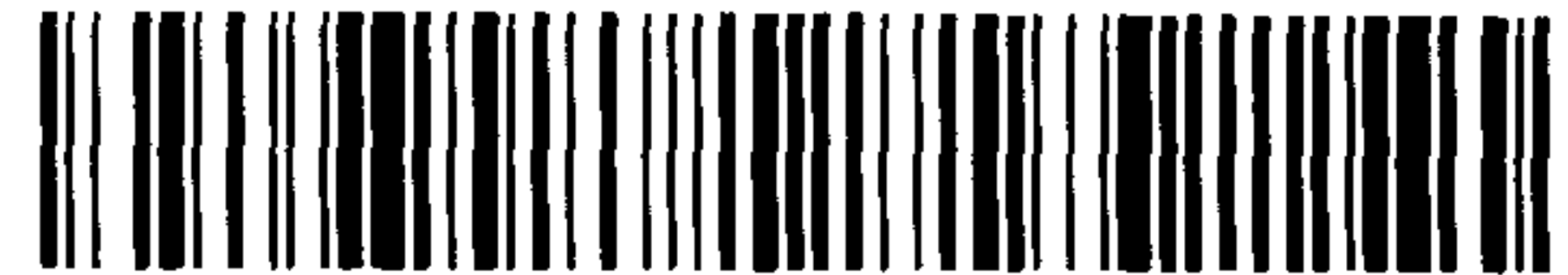

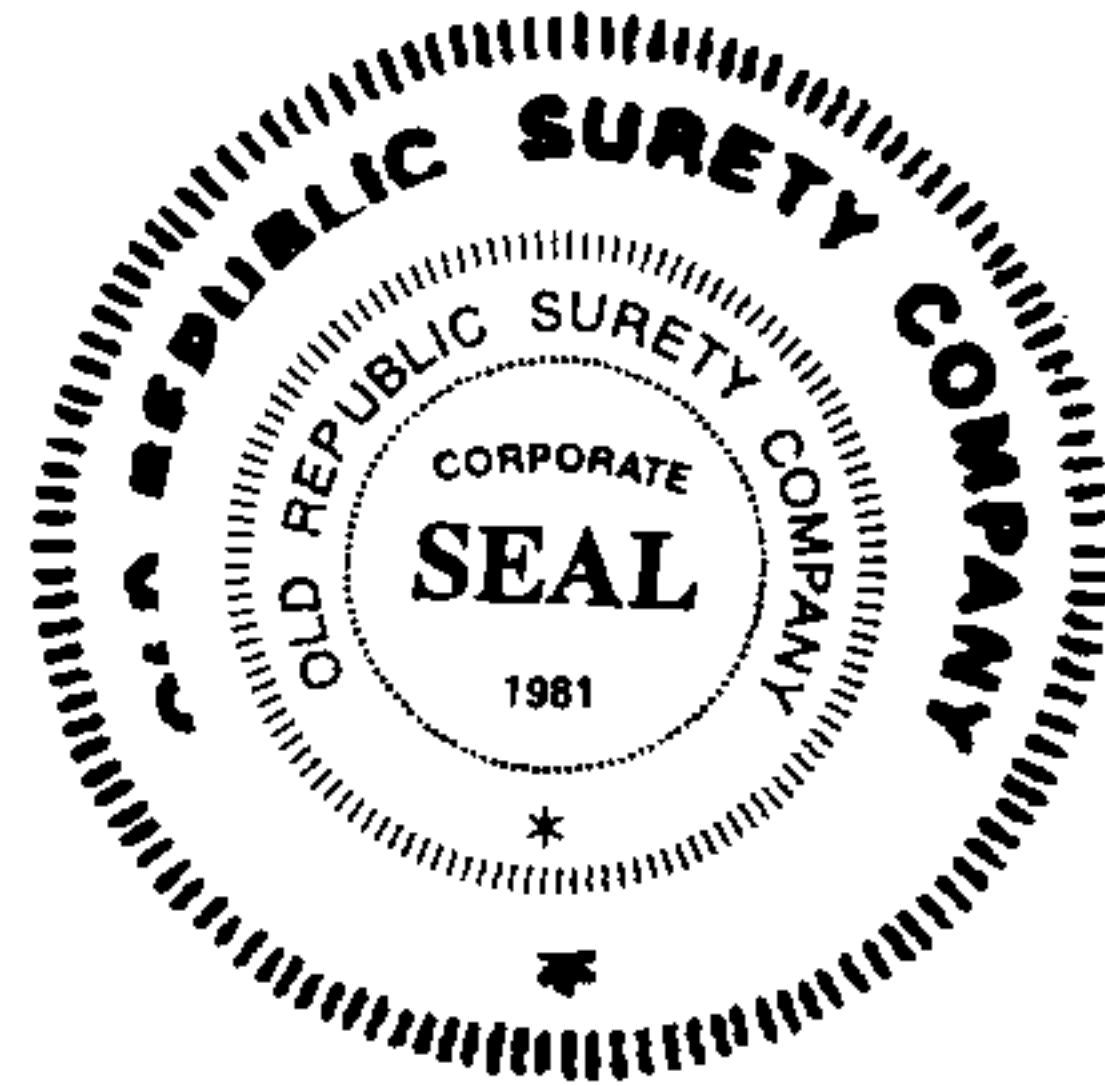

POWER OF ATTORNEY
