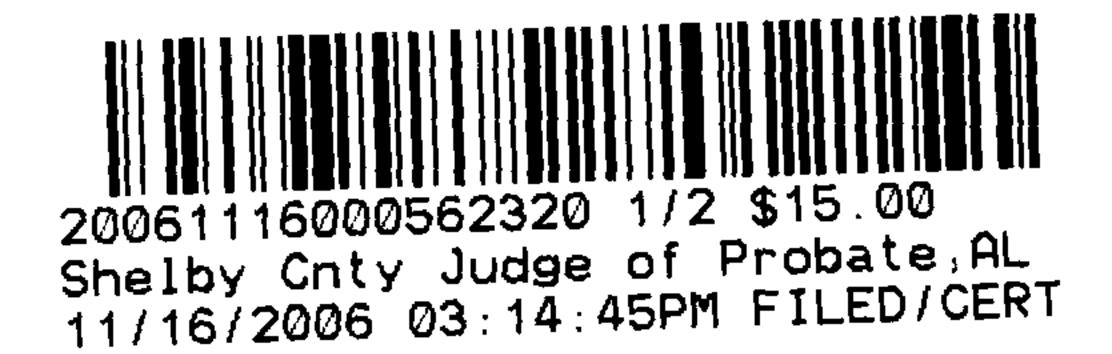

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That in consideration of Three Hundred Sixty Thousand and 00/100 Dollars (\$360,000.00) to (the "Grantor"), CHARLES G. KESSLER, JR., a married man, in hand paid by DESIGNMARK BUILDERS, LLC, an Alabama limited liability company (the "Grantee"), the receipt and sufficiency of which is hereby acknowledged, Grantor does by these presents grant, bargain, sell and convey unto Grantee, subject to the covenants, conditions and other matters set forth below, the real estate situated in Shelby County, Alabama, more particularly described as follows (the "Property"):

Lot 18, 19, 20, 21, 25, 26, 27, 28, 29, and 35, according to the map or survey of Mountain Lake Subdivision, as recorded in Map Book 31, Page 129, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:

- 4. Right of way to Alabama Power Company, recorded in Book 217, Page 90, and Book 232, Page 709, of the Official records of Shelby County, Alabama.
- Right of way to Shelby County, Alabama, recorded in Book 1999, Page 34876, of the Official records of Shelby County, Alabama.

TO HAVE AND TO HOLD unto Grantee, and Grantee's successors and assigns forever, subject, however, to the matters described above.
