

## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 13, 2005, James T. Cooper and Jane L. Cooper, Husband and Wife, Party of the First Part, executed a certain mortgage to Household Finance Corporation of Alabama, which said mortgage is recorded in Instrument No. 20050613000287950, in the Office of the Judge of Probate of Shelby County, Alabama; and
