AMENDMENT AND MODIFICATION AGREEMENT

THIS AMENDMENT AND MODIFICATION AGREEMENT entered into this the <u>28th</u> day of <u>November</u>, <u>2006</u>, on behalf of <u>Jackie Williams Company</u>, <u>Inc</u>. (hereinafter called the "Mortgagor) in favor of <u>First American Bank</u>, an Alabama banking corporation (the "Lender").

B. The Mortgagor has requested the Lender to exchange Lot 8, as described above, for Lot 6 described as:


