## LOAN MODIFICATION AGREEMENT

THIS AGREEMENT is made and entered into between Coats & Co., Inc. (hereinafter referred to as the "Mortgagee") and Ronald L. Walker and spouse, Katherine S. Walker (hereinafter referred to as the "Mortgagor").


## RECITALS

- A. Mortgagee is the owner and holder of that certain Mortgage, Deed of Trust, or Deed to Secure Debt (hereinafter referred to as the "Security Instrument") dated April 3, 2006, made by the Mortgagor to the Mortgagee, recorded in Book 20060411000168620, at page(s) 1/4, of the Public Records of Shelby County, Alabama; securing a debt evidenced by a promissory note (hereinafter referred to as the "Note") dated April 3, 2006, in the original amount of \$500,000. The Security Instrument encumbers property more particularly described in the Security Instrument.
- B. Mortgagor, the owner in fee simple of all of the property subject to the Security Instrument, has requested Mortgagee to modify the Note and Security Instrument, and the parties have mutually agreed to modify the terms thereof in the manner hereinafter appearing.

**NOW, THEREFORE**, in consideration of the mutual promises and agreements hereinafter exchanged, and in consideration of the sum of Ten Dollars and Zero Cents (\$10.00), receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. The unpaid principal balance of the loan is \$500,000, and the interest will be paid to the effective date of this agreement.
- 2. The terms and provisions of the Note are amended and modified in accordance with the following, but all other terms and conditions of the Note remain unchanged:
  - The Principal Sum ("Loan Amount") is changed from \$500,000 to \$508,000.
