WHEREAS, heretofore on July 15, 2004, **Melissa Kenney and William J. Kenney, husband and wife, Party of the First Part**, executed a certain mortgage to **Argent Mortgage Company, LLC**, which said mortgage is recorded in Instrument No. 20040730000424210, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Wells Fargo Bank, NA as Trustee; and
