

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That in consideration of Forty-Five Thousand and 00/100 Dollars (\$45,000.00) to DESIGNMARK BUILDERS, LLC, an Alabama limited liability company (the "Grantor"), in hand paid by CHARLES C. TANNER, JR. (the "Grantee"), the receipt and sufficiency of which is hereby acknowledged, Grantor does by these presents grant, bargain, sell and convey unto Grantee, subject to the covenants, conditions and other matters set forth below, the real estate situated in Shelby County, Alabama, more particularly described as follows (the "Property"):

Lot 30, according to the map or survey of The Reserve at Timberline, as recorded in Map Book 34, Page 117 A, B, and C, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:

- Taxes and assessments for the year 2007, and taxes for subsequent years, not yet due and payable.
- Mineral and mining rights as recorded in Book 34, Page 130, Book 240, Page 935, Book 34, Page 917, Book 37, Page 593, Book 239, Page 526, Page 526, and Book 271, Page 918, of the Official records of Shelby County, Alabama.
- Right of way to Alabama Power Company, recorded in Book 323, Page 131, Book 219, Page 75, and Book 2002, Page 6355, of the Official records of Shelby County, Alabama.
- Restrictions and Covenants as recorded in Book 2005, Page 14193, of the Official records of Shelby County, Alabama, but omitting any covenants or restrictions, if any, based upon race, color, religion, sex, sexual orientation, familial status, marital status, disability, handicap, national origin, ancestry, or source of income, as set forth in applicable state or federal laws, except to the extent that said covenant or restriction is permitted by applicable law.

TO HAVE AND TO HOLD unto Grantee, subject to the matters described above, his heirs and assigns forever.

By acceptance of this Deed, Grantee hereby covenants and agrees for itself and its heirs, successors, assigns, licensees, lessees, employees and agents that the Released Parties shall not be liable for, and no action shall be asserted against the any of the Released Parties for loss or damage on account of injuries to the Property or to any buildings, improvements, or structures now or hereafter located upon the Property, or on account of past or future injuries to any owner, occupant or other person in or upon the Property, which are caused by, or arise as a result of soil and/or subsurface conditions, known or unknown (including, without limitation, underground mines, sinkholes or other geological formations or conditions) under or on the Property or any other property now or hereafter owned by any of the Released Parties, whether contiguous or non-contiguous to the Property sold hereunder. For purposes of this paragraph, the term "Released Parties" shall mean and refer to (i) Designmark Builders, LLC; (ii) the agents, employees, contractors and subcontractors of Designmark Builder, LLC; (iii) any successors and assigns of Designmark Builders, LLC; (iv) the City of Vestavia Hills, Alabama, a municipal corporation, its officials, agents, employees and contractors, and any and all other political subdivisions, governmental entities, agencies, authorities, and/or bodies. This covenant and agreement shall run with the land conveyed hereby as against Grantee, and all persons, firms, trusts, partnerships, limited partnerships, corporations or other entities holding under or through Grantee.
