Subcontractor represents that all sales and use taxes if any, applicable to any materials furnished by or for Subcontractor have been paid in full. Subcontractor represents that all contributions, taxes or payments required to be made because of employees of the Subcontractor by the Federal and State Unemployment Compensation Acts, Social Security Acts, or any other amendments thereto, and by all other or future Acts, State of Federal, have been paid by the Subcontractor.
