**ARTICLES OF ORGANIZATION
OF
GREYSTONE DEVELOPMENT, LLC**

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is Greystone Development, LLC.
2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until December 31, 2057, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. The purpose for which this Limited Liability Company is organized is to acquire and develop real estate, and to engage in the transaction of any lawful business permitted under the laws of the State of Alabama.

7. The cessation of membership of one or more Members will not result in the dissolution of the Limited Liability Company.

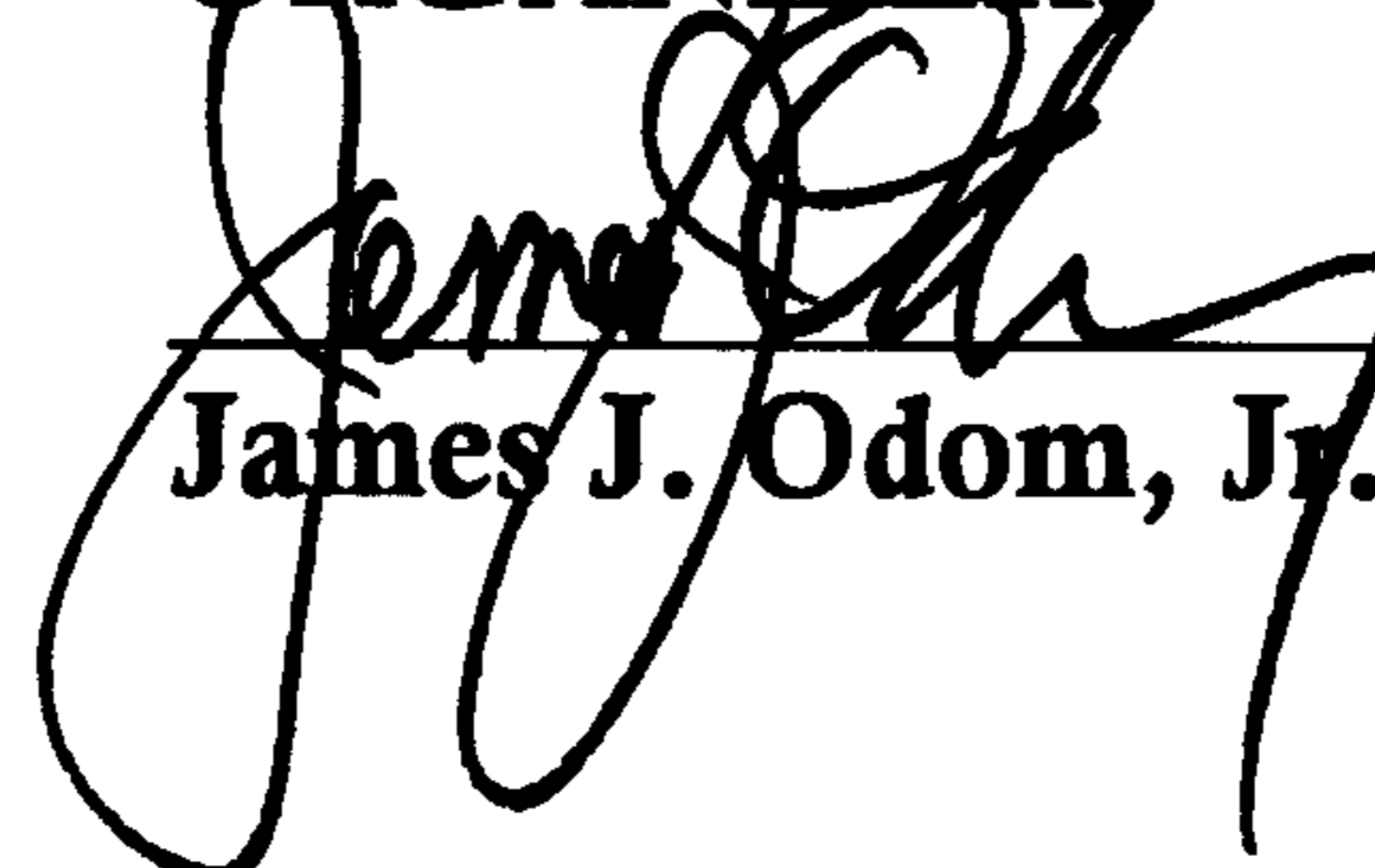
