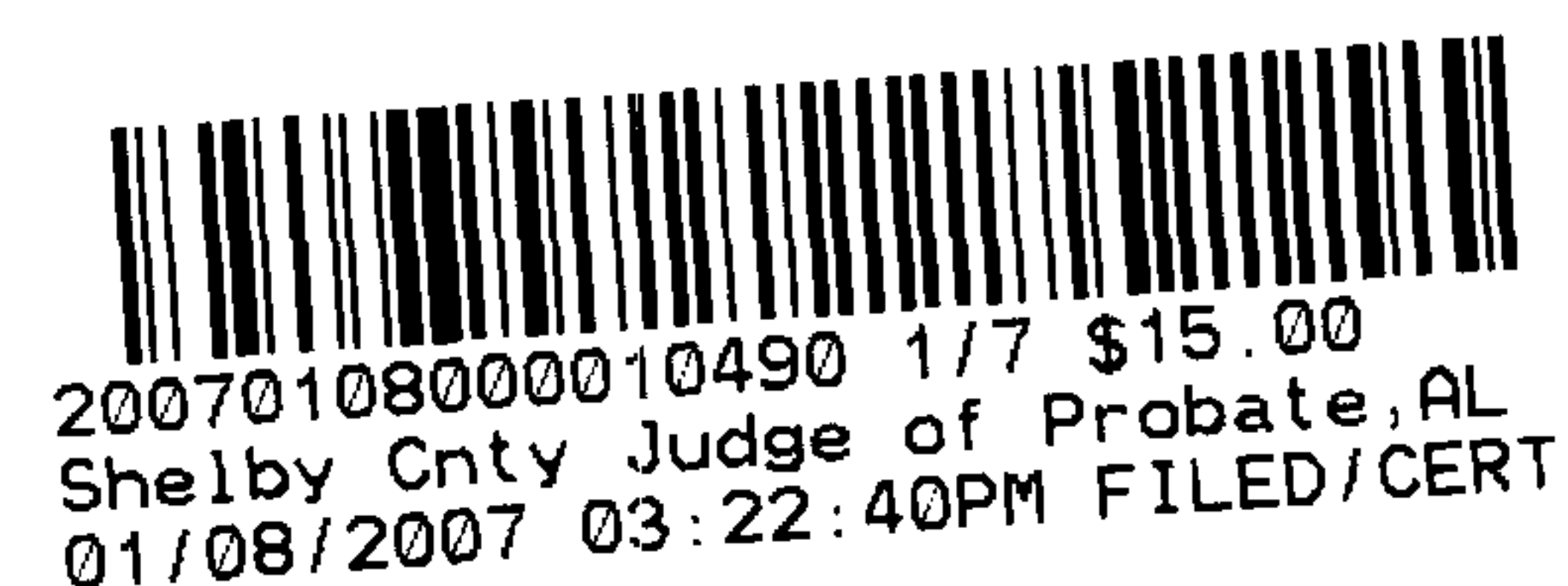

**ARTICLES OF CORRECTION
OF
ALABAMA WIRE, INC.**

Pursuant to the provisions of Section 10-2B-1.24, Code of Alabama, 1975, the undersigned corporation submits the following Articles of Correction:

**ARTICLE I.
Document Previously Filed**

On May 3, 2006, Articles of Dissolution (copy attached) were filed with the Shelby County Judge of Probate. The name of the corporation shown on the Articles of Dissolution is **Alabama Wire, Inc.** which was the name of the corporation at its incorporation on April 28, 1977.

**ARTICLE II.
Incorrect Statements**

The incorrect statements in the Articles of Dissolution were:

- (a) that the name of the corporation was **Alabama Wire, Inc.** as of the date of that filing (on April 10, 2006, Alabama Wire, Inc. filed **First Articles of Amendment to the Articles of Incorporation of Alabama Wire, Inc.** (copy attached), which changed the name of the corporation to **J.B. Wood Wire, Inc.**),
- (b) that the corporation was incorporated in Shelby County (the corporation was, in fact, incorporated in Jefferson County), and
- (c) that the date of incorporation was April 26, 1977 (the date of incorporation was, in fact, April 28, 1977).

**ARTICLE III.
Correct Statements and Other Corrective Action Being Taken**

Based on the information contained in Article II(a), the name of the corporation in the Articles of Dissolution filed on May 3, 2006, should be **J.B. Wood Wire, Inc.** Based on the information contained in Article II(b), Articles of Dissolution for this corporation should state that Jefferson County is the county of incorporation and that the date of incorporation is April 28, 1977. Based on the correct county of incorporation, the Articles of Dissolution filed with Shelby County on May 3, 2003 should have been filed in Jefferson County. The corporation has now correctly filed Articles of Dissolution (see attached copy) in Jefferson County.

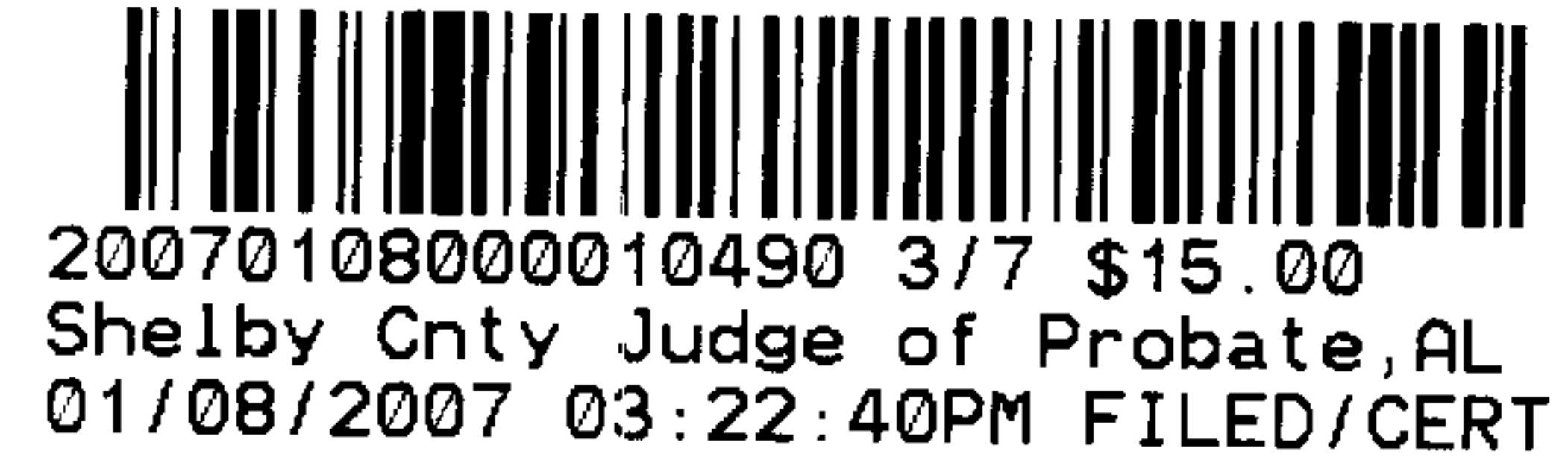



- ARTICLE I.* The name of the corporation is J. B. Wood Wire, Inc. The corporation was incorporated on April 28, 1977 in Jefferson County.
- ARTICLE II.* The dissolution was authorized on the 3rd day of May, 2006.



