There is attendant on this property an easement being 20 feet in width and running along the East boundary line as shown on the survey by Joseph E. Conn, Jr., dated January 30, 1981, Ala. Reg. No. 9049. Said easement is for the use of the property South of this tract. Easement is for access and installation of local utilities only.

Parcel I:

Commence at the southeast corner of the northeast quarter of the northwest quarter of Section 15, Township 21 South, Range 3 West, Shelby County, Alabama, and run thence South 89 degrees 57 minutes 44 seconds West along the south line of said quarter-quarter a distance of 764.57 feet to a point; thence run North 01 degrees 42 minutes 38 seconds west a distance of 660.00 feet to a point; thence run North 89 degrees 57 minutes 44 seconds east a distance of 200.00 feet to a point; thence run north 01 degrees 42 minutes 38 seconds west a distance of 221.39 feet to a point; thence run North 69 degrees 29 minutes 38 seconds west a distance of 158.06 feet to a point; thence run North 21 degrees 16 minutes 04 seconds east a distance of 98.90 feet to a set rebar corner and the point of beginning of the property being described; thence run North 21 degrees 16 minutes 04 seconds east a distance of 116.97 feet to a rebar corner on the southerly margin of a public street or road; thence run North 68 degrees 38 minutes 56 seconds west along said margin of said road a distance of 107.01 feet to the P.C. of a curve to the right having a central angle of 08 degrees 20 minutes 00 seconds and a radius of 234.63 feet; thence run northwesterly along the arc of said curve an arc distance of 34.13 feet to the P.T. of a said curve; thence run North 60 degrees 18 minutes 56 seconds west along said margin of said road a distance of 62.21 feet to the P.C. of a curve to the left having a central angle of 128 degrees 50 minutes 07 seconds and a radius of 25.0 feet; thence run along the arc of said curve an arc distance of 58.21 feet to the P.T. of said curve; thence run south 06 degrees 42 minutes 31 seconds East along said margin a distance of 55.17 feet to a corner; thence run north 89 degrees 07 minutes 20 seconds east a distance of 20.19 feet to a corner; thence run South 02 degrees 32 minutes 53 seconds east a distance of 77.50 feet to a corner; thence run South 76 degrees 18 minutes 57 seconds east a distance of 153.75 feet to the point of beginning.
