THIS AGREEMENT is made and entered into on this 22 day of December 2006, by AmSouth Bank (hereinafter referred to as "AmSouth") in favor of HOMECOMINGS FINANCIAL, LLC, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

AmSouth loaned to LANCE S. HOPPER (the "Borrower", whether one or more) the sum of \$85,000.00. By its acceptance of this agreement, the Borrower agrees to pay the Subordination Fee set out in the AmSouth Subordination Request Form.
