FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of May, 2004, John F. Kizer, Jr., a married man and wife, Debbie Kizer, executed that certain mortgage on real property hereinafter described to Ameriquest Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. WHEREAS, Star Properties, LLC was the highest bidder and best bidder in the amount of One Hundred Eighteen Thousand Sixteen and 00/100 Dollars (\$118,016.00) on the indebtedness secured by


