THIS FORECLOSURE DEED made this 9th day of January, 2007, between STEPHEN B. DEVANE, a single man, Party of the First Part, and CITICORP TRUST BANK, FSB, F/K/A TRAVELERS BANK & TRUST, FSB, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said STEPHEN B. DEVANE, a single man, heretofore executed to TRAVELERS BANK & TRUST, FSB, herein called the Mortgagee, a certain mortgage dated August 31, 2001, and recorded in Instrument Number 2001-38734, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and the Party of the Second Part was owner thereof at the time of the sale hereinafter mentioned; and
