POWER OF ATTORNEY





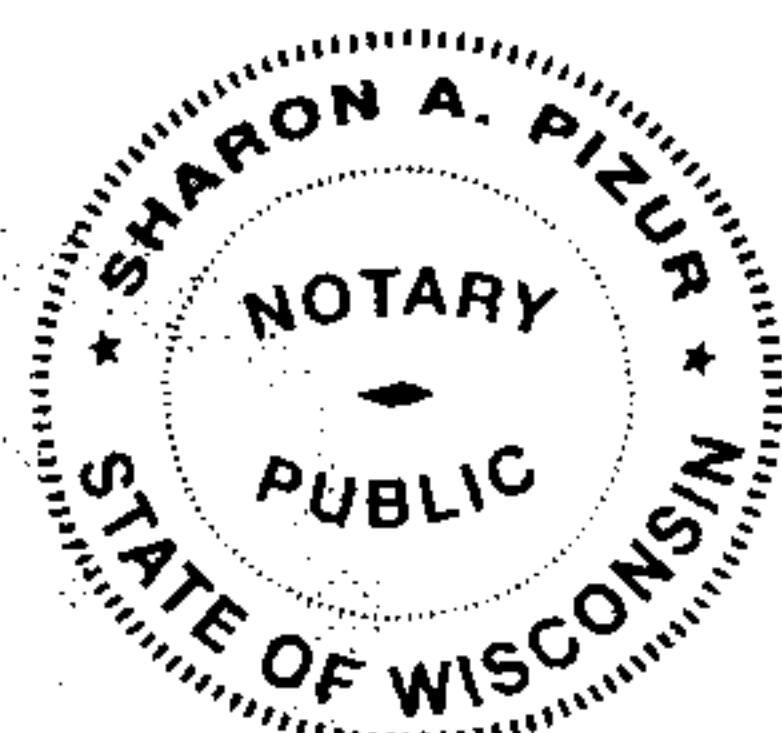
