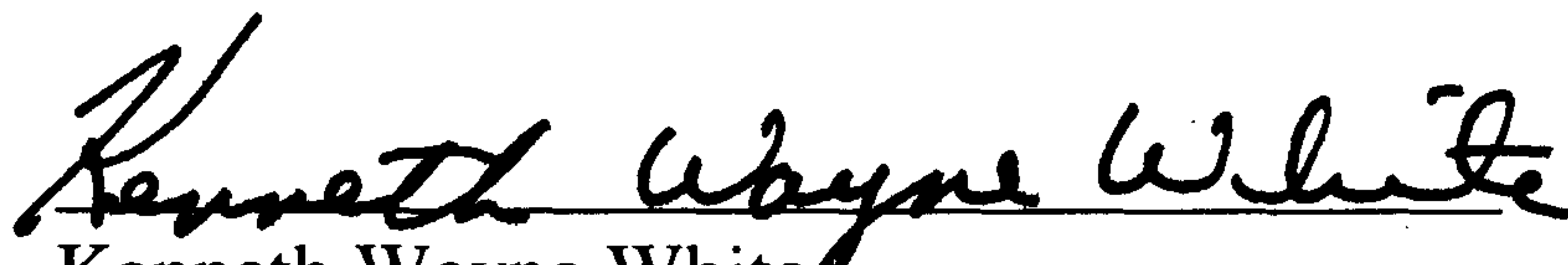

A 40 foot utility easement for a water line situated in the Northwest quarter of the Northeast quarter of Section 5, Township 21 South, Range 1 East, Shelby County, Alabama, Lying West of also parallel with and adjacent to a 100 foot Alabama Power Company Transmission Line Easement. The centerline of said 40 foot easement being more particularly described as follows:

Commence at the Southeast corner of the Northwest quarter of the Northeast quarter said Section 5; thence run West along the South line of said Northwest quarter of the Northeast quarter for a distance of 133 feet more or less, to the point of beginning of the centerline of said 40 foot easement herein described, said point lying 20 feet West of perpendicular to the West right of way line of said 100 foot Alabama Power Company Transmission Line Easement, thence turn an angle to the right and run in a Northwesterly direction parallel with said Alabama Power Company Transmission Line Easement, for a distance of 655 feet more or less to a point on the North line of the above described parcel, and point of termination of the 40 foot easement herein described. Said easement contains 0.60 acres, more or less.
