Subject to:

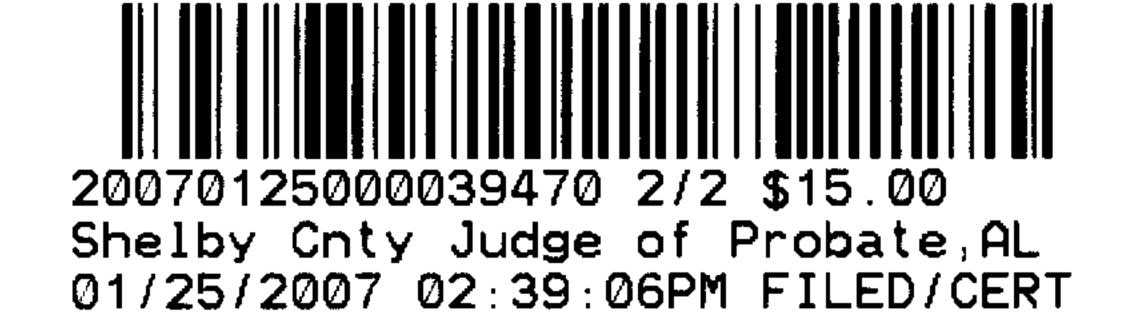
