POWER OF ATTORNEY

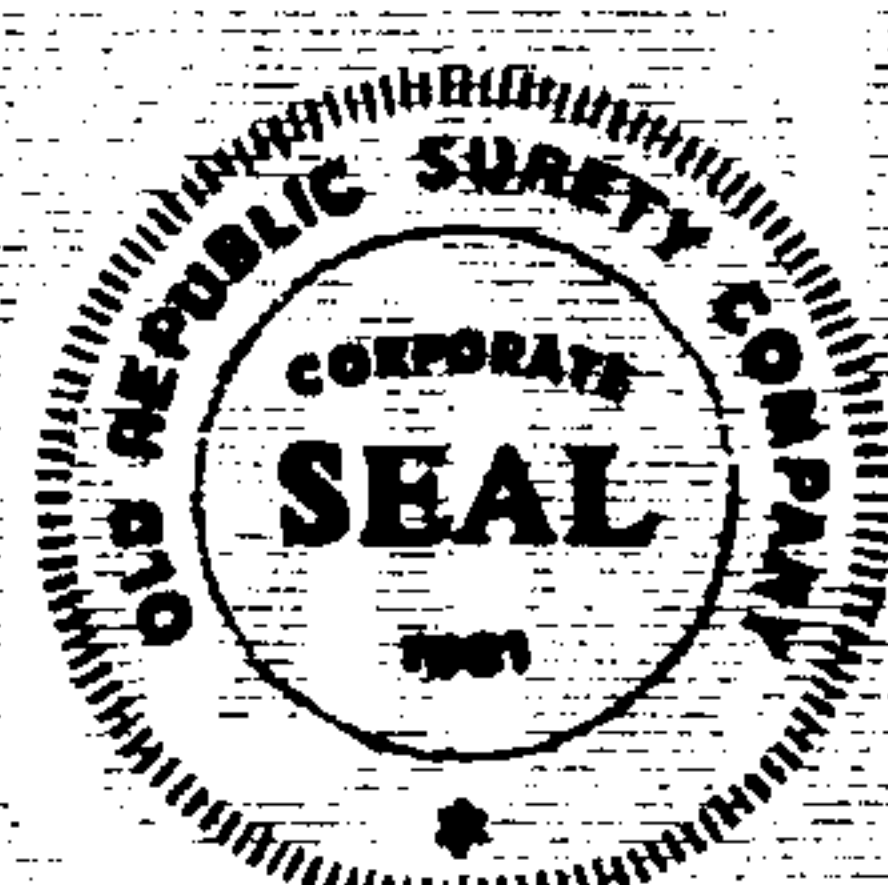

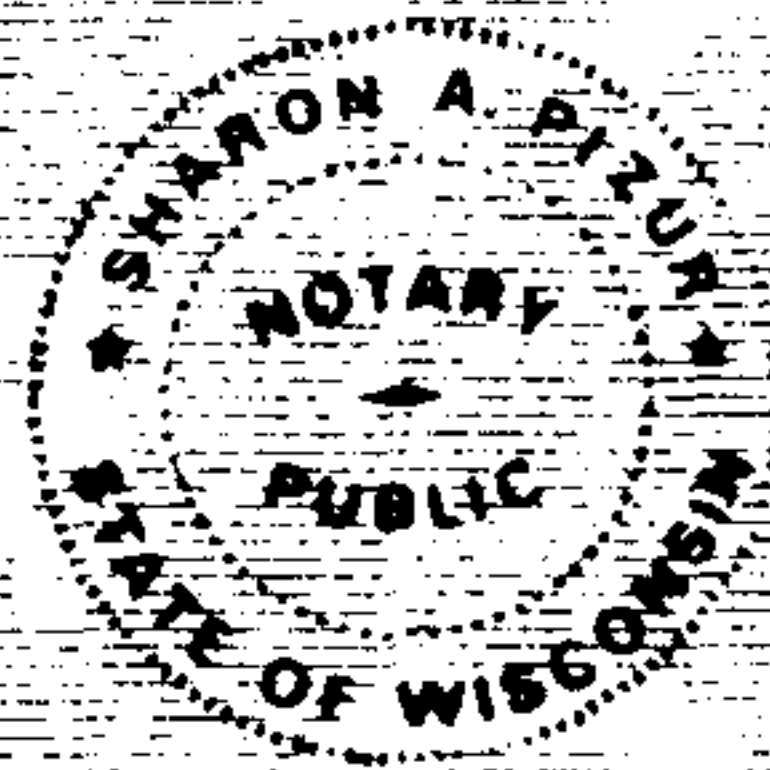

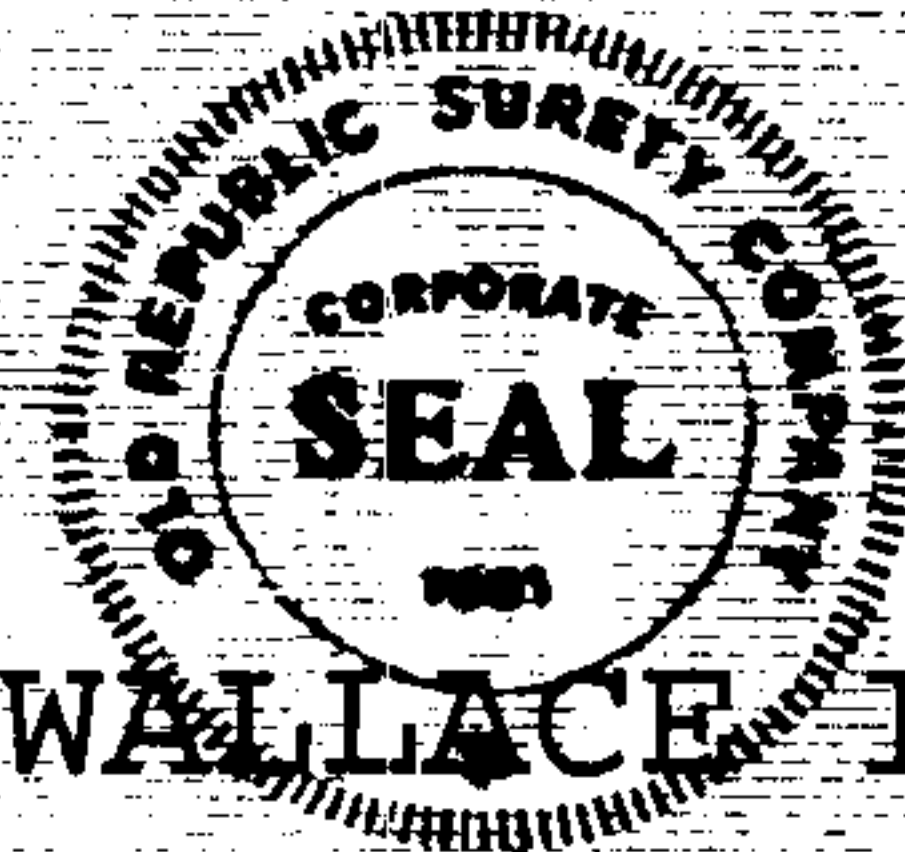
