KNOW ALL MEN BY THESE PRESENTS, That, in consideration of \$235,000.00 to the undersigned Grantor(s), David J Wages and Donna J Wages, Husband and Wife, in hand paid by the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor(s) does by these presents, grant, bargain, sell and convey unto Michael King and Kimberly King (herein referred to as "Grantees") the following described real estate, situated in Shelby County, Alabama, to-wit:
