EXHIBIT "A"

PARCEL I:

Commence at the Northwest corner of Section 26, Township 21 South, Range 1 West, and run South 1°44' East along the West boundary line of said section a distance of 849.41 feet to a point on the Northwest 40 foot right of way line of a county highway; thence turn an angle of 124°09' to the left and run North 54°07' East along said Northwest 40 foot right of way line a distance of 423.25 feet to the point of beginning; thence continue North 54°07' East along said right of way line a distance of 402.35 feet to a point; thence turn an angle of 55°34' to the left and run North 1°27' West a distance of 425.94 feet to a point; thence turn an angle of 90°00' to the left and run South 88°16' West a distance of 336.19 feet to a point; thence turn an angle of 90°00' to the left and run South 1°44' East a distance of 651.80 feet to the point of beginning.

Said parcel of land is lying in the NW ¼ of NW ¼ of Section 26, Township 21 South, Range 1 West.

PARCEL II:

Being all that parcel or tract of land lying in Section 22, Township 21 South, Range 1 West, Shelby County, State of Alabama, and being more particularly described as follows:

Commencing at the Northeast corner of Section 27; and thence running in a Southerly direction 100.00 feet +/- to a point; thence running in a Westerly direction 1727.9 feet +/- to an iron pipe found on the Western right of way of Industrial Road; thence running with said right of way South 01°47'21" West for 62.80 feet to an iron pin set which is the Point of Beginning; thence from said beginning point running with the Northern line of a 60.00 foot easement (per D.B. 1996, page 31713) North 89°09'40" West for 399.89 feet to an iron pin found; thence running with the line of Gulf States Paper Corp.
